The Higher Education Emergency Relief Fund II (HEERF II) is authorized by the Coronavirus Response and Relief Supplemental Appropriations Act 2021 (CRRSAA), and signed into law on December 27, 2020. The CRRSAA authorize \$81.88 billion in support of education. HEERF III is authorized by the American Rescue Plan (ARP) and signed into law on March 11, 2021. The ARP authorizes \$39.6 billion in support to institutions of higher education to serve students and ensure learning continues during the COVID-19 pandemic.

WMed signed and returned to the U.S. Department of Education the Certification and Agreement for the CRRSAA and ARP with the assurance that the medical school will use the applicable amount of funds to provide Emergency Financial Aid Grants to Students. On February 3, 2021, the medical school was awarded a total of \$115,890 from CRRSAA, with \$39,282 designated to use in support of students. On May 20, 2021, the medical school was awarded \$214,638 under APR, with \$107,319 allocated in support of students.

Institutions have the responsibility of determining how grants will be distributed to students, how the amount of each student grant is calculated, and the development of any instructions or directions that are provided to students about the grant. The medical school disbursed student grants of \$39,282 under CRRSAA and \$107,319 under ARP on September 2, 2021. Grants ranged from \$300 up to \$625. All 348 enrolled students were considered and received the grant, with the highest amounts given to the students with the greatest demonstrated need. Students were not required to complete an application. Grant amounts were determined using information from the Free Application for Federal Student Aid, the Expected Family Contribution (EFC), and/or previous Pell grant recipient. Students that previously received a Pell grant, or had an EFC below 5847 were placed in Tier 1 and received the maximum grant. All other enrolled students were placed in Tier 2 and received the minimum grant.

Students were notified of the CRRSAA and ARP on August 27, 2021 via email. Information regarding HEERF funds remains on the medical school's website. Additional communication, directions or guidance to the students has been through emails and/or student weekly publications.
